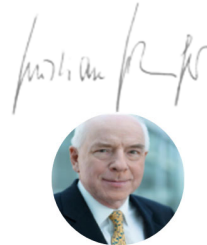

EVENTS

With our regular events, we bring together researchers and practitioners to discuss intriguing corporate governance issues and trends. These events help us to build a strong corporate governance community and to shape our research agenda.

We are currently running four series of events, each with a distinct purpose and scope:

- Our **Annual Conferences** welcome a large audience interested in stimulating corporate governance topics at a full-day event held at the Frankfurt School. Distinguished speakers from business and academia give presentations and hold panel discussions under overarching corporate governance themes. With Q&A sessions and lunch/coffee breaks, the participants are an active part of the dialogue.
- **Corporate Governance Working Breakfasts** are held quarterly with the aim of promoting an intensive professional exchange on current developments in the field of corporate governance. After a 45-minute presentation a 15-minute Q&A session allows to discuss the relevant topics.
- Our **Round Table discussions** aim to stimulate an in-depth discussion by senior experts of focusing on a specific corporate governance topic.
- Starting in 2023, we added a new event format with **Joint Conferences**, in which we deepen the exchange of ideas with other highly rated academic institutions, such as ESMT Berlin, by co-hosting joint conferences.

In 2023, we hosted a total of eight events across these 4 series, the details for each of these events are given below:

Round table discussion on the reform of supervisory board law

On February 13, 2023 we hosted a round table led by Prof. Dr. Julia Redenius-Hövermann and Prof. Christian Strenger, to discuss the topic "Reform of Supervisory Board Law" with leading representatives from the judiciary, practice, and academia.

It was noted that good corporate governance requires significantly more time and presence to manage an increasingly demanding, complex programme, especially due to the double transformation in digitalisation and sustainability.

3rd Annual Conference: "Drivers or Driven? The role of companies, investors and regulators in the green transformation"

In our third CGI Annual Conference on June 15, 2023, titled "Drivers or Driven? The Role of Companies, investors, and Regulators in the Green Transformation". The in-person conference addressed the pressing issues of climate change and sustainable finance, highlighting topics such as the European Green Deal, shareholder engagement on climate change, financing green innovation, the impact of ESG ratings and proxy advisors on the green transformation, as well as the potential and limitations of regulation in driving the green transformation. The conference with 80 participants provided a platform for valuable insights and diverse perspectives from leading experts to address important issues on climate policy and the sustainable transformation of business and financial systems. The speakers included Amra Balic - Blackrock, Prof. Dr. Alexander Bassen - Universität Hamburg, Prof. Dr. Andreas Hoepner - UC Dublin, Prof. Dr. Elmar Kriegler - Universität Potsdam, Dr. Paolo Krischak - Deutsche Bundesbank, Claudia Kruse - APG Asset Management, Dr. Friederike Rotsch - then Merck KGaA, Dr. Theodor Weimer - Deutsche Börse AG, and Prof. Dr. Norbert Winkeljohann - Bayer AG.

Festschrift Presentation to Professor Christian Strenger

On 22 June 2023, Professor Christian Strenger's influence and work on corporate governance matters were acknowledged in a publication titled "Vom Wert guter Governance". The presentation at the Frankfurt School was attended by 70 participants from all over the world from business, art, culture, and sport. Christian Strenger's newly established Stipendienfonds will fund Master Scholarships for good governance at Frankfurt School.

Round table discussion on Supervisory Board Governance

On September 5, 2023 we hosted a round table discussion titled "Aufsichtsrats-Governance großer Wirtschaftsprüfungs-Gesellschaften" with leading personalities in the corporate governance field. The discussion focussed on improving the governance of their Supervisory Boards and the possibilities for better reporting on the overall governance of the firms.

Joint conference with ESMT Berlin: Private Capital — Key to retirement provision and transformation in Europe

On November 7, Prof. Christian Strenger and Prof. Dr. Jörg Rocholl, President of ESMT Berlin, hosted an event with representatives from politics, finance, and academia at the ESMT campus to discuss the pivotal role of private capital markets in the European retirement system and green transformation.

Prof Dr Axel Börsch-Supan provided a scientific perspective on the current state of the German retirement system. Dr Florian Toncar (FDP), State Secretary for Finance spoke about the German government's plans to use the potential of the capital market for transformation and retirement provision. Prof Strenger outlined the European capital market perspective and used the Dutch and Swedish pension systems as examples to stress that German pension systems urgently need change. Prof Dr Dirk Honold from Technische Hochschule Nürnberg, Anja Mikus from KENFO, and Hans Joachim Reinke from Union Investment provided practical impulses for the generation of private capital. Prof Jörg Rocholl, Alexander Schulz from the Deutsche Bundesbank, and Robin Winkler from Deutsche Bank led the final discussion for the concept of a European Capital Market Union.

OECD POLICY WORK

The Institute attaches particular importance to contributing to the policymaking process and actively takes part in consultation processes in the corporate governance field. In 2023, the OECD held consultations on the Draft Revisions for the latest edition of the Group 20 OECD Corporate Governance Principles and the OECD Guidelines on Corporate Governance of State-Owned Enterprises. The Institute contributed to both undertakings by Professor Strenger and Gül Demirtas.

Governance Guidelines for Sustainability in SMEs

On March 13, 2023, the Expert Commission for the Development of Sustainable Governance Principles for SMEs, chaired by Professor Dr. Julia Redenius-Hövermann and Professor Dr. Christina E. Banner from Justus-Liebig-University Gießen, published guidelines for SMEs that comprise practical and science-based sustainable governance principles. The goal is to facilitate the address of ESG issues in the corporate governance of SMEs and set targets for their sustainable orientation.

On March 27, 2023 the Guidelines were presented to the Hessian Minister of Justice, Professor Dr. Roman Poseck who remarked that they usefully reflect the special features of medium-sized enterprises. The goal is to sensitive SMEs to embrace sustainability without forcing overregulation.

RESEARCH AND PUBLICATIONS

The Institute adopts an interdisciplinary research approach to combine academic and professional expertise in law and finance. We actively contribute to the global and European corporate governance discussion with publications in academic and professional journals. Our blog and media contributions help us further disseminate our perspectives and research insights outside the academic circles and across the business community.

In 2023, numerous publications were presented, including articles in leading academic journals and guest posts focusing on current governance topics.
